



ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be 1680 Michigan Actuation, LLC, a Florida limited liability company (the "Company").

ARTICLE V -- CAPITAL CONTRIBUTIONS
