ARTICLES OF ORGANIZATION

OF

SADDLEBROOK APARTMENTS, LLC

The undersigned hereby certifies that it has formed a limited liability company under the State of Florida.

ARTICLE I

Name

The name of the limited liability company shall be SADDLEBROOK APARTMENTS, LLC.

ARTICLE II

Address and Place of Business

The mailing address and principal place of business for the limited liability company is: 1995

ARTICLE III

Period of Duration

The limited liability company shall begin existence on the day of filing, and shall continue into perpetuity, or until dissolved in a manner provided by law or by an operating agreement adopted by the Members of the limited liability company.

The limited liability company shall have the power to:



- Indemnify a Member or any other person to the same extent as a corporation may (i) indemnify any of the directors, officers, employees, or agents of the corporation against expenses actually and reasonably incurred by him or it in connection with the defense of an action, suit, or proceeding, whether civil or criminal, in which he or it is made a party.
 - Cease its activities and surrender this Certificate of Organization. (k)
- (1)Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the limited liability company is organized.
- Transact any lawful business which the Members or the managers find to be in aid of (m) governmental policy.

- Pay pensions and establish pension plans, profit-sharing plans and other incentive (n) plans for any or all of its managers and employees.
- (o) Be a promoter, incorporator, general partner, limited partner, Member, associate, or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other enterprise.
 - (p) Have and exercise all other powers necessary or convenient to effect its purposes.

ARTICLE VI

Registered Office and Registered Agent

Notwithstanding the death, retirement, resignation, expulsion or bankruptcy of a Member, all contracts authorized by the limited liability company and executed by such Member in his or its representative capacity shall survive and shall inure to the benefit of the limited liability company.

Restrictions on Membership

The operating agreement shall be repealed or altered only by the Members of the limited liability company, in the manner now or hereafter prescribed by the laws of the State of

Voting

Each Member's vote shall be weighted in proportion to the Member's initial capital accounts plus any additional capital contributed by the Members at the request of the limited liability company.
