ARTICLES OF ORGANIZATION OF FAIRHOMES PERIDOT PROPERTIES, LLC

The undersigned certifies that he is acting as an authorized representative for the purpose of forming a limited liability company under the laws of the State of Florida providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further certifies that the following Articles shall serve as the charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be **FAIRHOMES PERIDOT PROPERTIES**, **LLC** and its principal office shall be located at 139 Main Street, Unit 203, City of Unionville, Province of Ontario, Country of Canada L3R 2G6, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate. - 5. To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform any service
