ARTICLE I- NAME

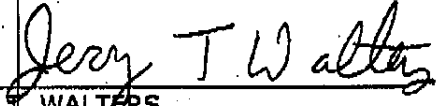
ARTICLE VI- MANAGEMENT

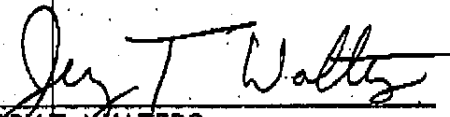
ARTICLE VII- AMENDMENT
