The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes; acknowledges, and files the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is 535 28th street, LLC (the "Company").


ARTICLE IX – Management
