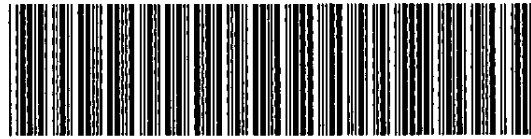




ARTICLE 6




