2. The Articles of Organization of the Limited Liability Company were filed on February 6, 2013 and assigned Florida Document No. L13000019681.

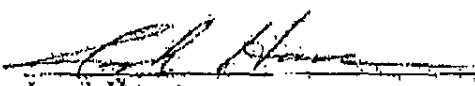
3. The Articles of Organization are hereby amended by deleting Article IV in its entirety and substituting therefor the following:

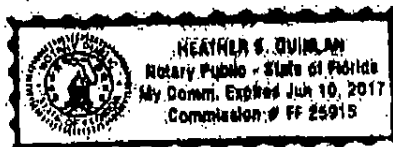
