## ARTICLES OF ORGANIZATION FOR

#### KEY INDUSTRIES, LLC

The undersigned, acting as the organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

#### ARTICLE I

#### Name

The Name of the Company is Key Industries, LLC

#### ARTICLE II

#### **Principal Office**

The mailing address and the street address of the principal office of the Company shall be:

#### **ARTICLE III**

#### Registered Agent and Office

The name and Florida street address of the initial registered agent for the Company shall be:

Timothy P. Lehman 9129 16<sup>th</sup> Ave. Cir. N.W. Bradenton, Florida 34209

The undersigned, having been named Registered Agent and designated to accept service of process for the above-stated Limited Liability Company pursuant to the provisions of Section 608.415, Florida Statutes, at the place designated herein, hereby accepts the appointment as registered agent and agrees to act in such capacity. The undersigned further agrees to comply with the provisions of all statutes relative to the proper and complete performance of the duties of registered agent, and acknowledges familiarity with, and accepts, the obligations of that position.

#### ARTICLE IV

#### Management of Business

The Company is to be managed by a manager or managers. The Initial Managers of the Company shall serve until the first annual meeting of the Members or until their successor is elected and qualified. The manager(s) of the Company will be elected annually by the Members. The Members may increase and decrease the number of managers from time to time; provided, however, there shall never be more than three (3) managers or less than one (1) manager. The managers shall be Members. The names and addresses of the Initial Managers of the Company are as follows:

#### **ARTICLE V**

#### Effective Date and Duration

The Company's existence shall be effective on January 29, 2013, and shall continue for in perpetuity from the effective date unless sooner dissolved in accordance with Section 608.441 of the Act.

#### **ARTICLE VI**

#### Purpose

The Company is created for the manufacturing of fiberglass boats; fiberglass boat components; marine parts, hardware, or supplies; and fiberglass storage tanks including, when applicable, the sale, installation and/or servicing of the aforementioned items, and to engage in any other lawful activity.

#### **ARTICLE VII**

#### Addition of Additional Members

Additional Members may be admitted only by the unanimous vote of the Members, upon terms and conditions established by the Members from time to time in their sole discretion.

#### **ARTICLE VIII**

#### Continuation of Business

The remaining Members shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any Member, or upon the occurrence of any other event which terminates the continued membership of a Member of the Company, all as more fully set forth in the Operating Agreement.

#### **ARTICLE IX**

#### **Powers**

The Company shall have all of the powers and authority set forth in Section 608.404 of the Act.

#### ARTICLE X

#### **Property**

- (a) <u>Ownership</u>. All property originally paid or transferred to the Company as contributions to capital by the Members, or subsequently acquired by purchase or otherwise on account of the Company, shall be the property of the Company.
- (b) <u>Title</u>. The title to all property of the Company shall be held in the name of the Company.
- (c) <u>Conveyances</u>. The Managers are, subject to the terms of the Operating Agreement, hereby authorized to convey and encumber title to all real and personal property of the Company by the execution on behalf of the Company of any and all agreements, deeds, mortgages, trust agreements, indentures, leases, conveyance documents, and all other certificates, instruments, and documents as are necessary, reasonable, or desirable to convey or encumber title to any real or personal property of the Company. Such execution shall be made by any Manager duly authorized to act for the Company. The signature and execution of such documents shall clearly set forth that the execution is on behalf of the Company and that the Manager is signing on behalf of the Company.

#### ARTICLE XI

#### Amendments

These Articles may be amended or restated at any time by a vote of the Members holding a majority of Voting Capital, and such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 608.411 of the Act.

#### **ARTICLE XII**

#### **Operating Agreement**

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles unless permitted herein. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth in the Operating Agreement.

#### **ARTICLE XIII**

#### **Contracting Debts**

No debt shall be contracted nor liability incurred by or on behalf of the Company except by its Managers, and no Member is authorized or empowered to contract debts or incur liabilities on behalf of the Company unless such Member is also a Manager.
