ARTICLES OF ORGANIZATION FOR BONITA OCEAN, LLC

The undersigned being the authorized representative of the managing members of the limited liability company referred to herein, executes and files these Articles of Organization and states as follows:

ARTICLE I - NAME

The name of this limited liability company is BONITA OCEAN, LLC.
