Stat. under the Florida Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on February 8, 2013:

DURATION**


The Company was formed as of February 8, 2013, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.


