AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF ADVENIR INVESTMENTS X, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Amended and Restated Articles of Organization (the "Articles").

ARTICLE I NAME

The name of the limited liability company is Advenir Investments X, LLC (the "Company").

ARTICLE II MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 17501 Biscayne Boulevard, Suite 300, Aventura, Florida 33160.

ARTICLE III REGISTERED AGENT AND OFFICE

ARTICLE VIII **AMENDMENT**

The Articles may be amended only in accordance with the Operating Agreement.
