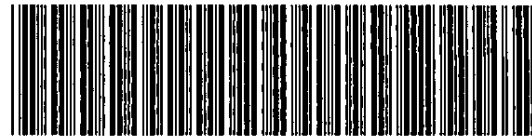

ARTICLES OF ORGANIZATION
OF
FORT WALTON BEACH FINANCIAL SERVICES, LLC

ARTICLE I - NAME

The name of this limited liability company is Fort Walton Beach Financial Services, LLC.

ARTICLE II - DURATION

This limited liability company shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE XII - DISSOLUTION






