ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name. The name of the limited liability company is MY SECRET VILLAGE, LLC ("Company").

Admission of New Members. A majority of the membership interests of the Company have the right to admit new members to the Company. Operating Agreement. The Operating Agreement of the Company shall be made, altered or rescinded by a majority vote of the Members of the Company at a meeting of the

Members; alternatively, all of the Members may sign a written statement adopting the proposed Operating Agreement or changes thereto.

ARTICLE XII

Preemptive Rights.
