**ARTICLES OF ORGANIZATION  
OF  
NAVARRE CONVENIENCE, LLC**

The undersigned, Beach Community Bank, having legal authority to contract, hereby presents these Articles of Organization of NAVARRE CONVENIENCE, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is as follows: Navarre Convenience, LLC. This limited liability company is referred to in these articles of organization as the "Company".

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

**ARTICLE VI - MANAGEMENT**
