ARTICLES OF ORGANIZATION OF NAVARRE CONVENIENCE, LLC

The undersigned, Beach Community Bank, having legal authority to contract, hereby presents these Articles of Organization of NAVARRE CONVENIENCE, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME
