affairs of the Company not inconsistent with law, this Instrument and the Florida Limited Liability Company Act.


**ARTICLE VI

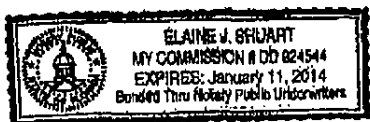


