**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
OCALA PALMS OPERATIONS, LLC**

Pursuant to Section 608.411 of the Florida Limited Liability Act, the undersigned, on behalf and in the name of OCALA PALMS OPERATIONS, LLC, a Florida limited liability company (the "Company"), adopts these Articles of Amendment.

1. The name of the Company is Ocala Palms Operations, LLC.
2. The Articles of Organization were filed effective February 11, 2013, and assigned a document number L13000021700.
3. The Articles of Organization of this Company are amended by modifying and amending Article I in its entirety and replacing it with the following:

**"ARTICLE I
