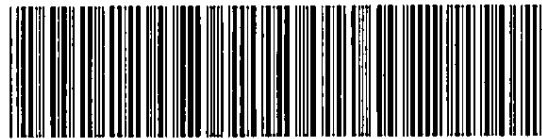

The undersigned, being the Manager of Florida Spine and Joint Institute, LLC, adopts the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:

**FIRST:** The name of the limited liability company filing these Amended and Restated Articles of Organization is FLORIDA SPINE AND JOINT INSTITUTE, LLC (the "Company").

**SECOND:** The Articles of Organization of the Company were filed with the Corporation Division of the Florida Department of State on February 12, 2013 under Document No. L13000022869.

**THIRD:** These Amended and Restated Articles of Organization were unanimously approved by the Members of the Company.


