The Company shall be member-managed. The initial managing member is RICHARD TEMSCH, whose address is 10641 Collar Drive, San Antonio, FL 33576.

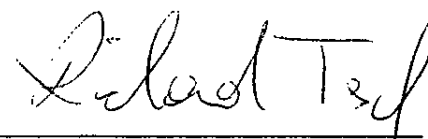
ARTICLE IV
