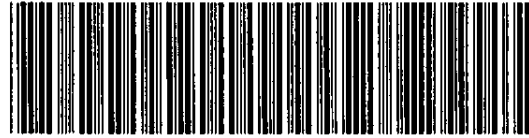

AMENDED ARTICLES OF ORGANIZATION
