
**ARTICLE I - ORGANIZATION NAME**

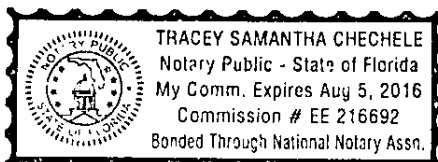


