**ARTICLES OF ORGANIZATION
OF
JTC FLORIDA KEM HOLDINGS, LLC**

The undersigned desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I – NAME

The name of the Company shall be JTC Florida KEM Holdings, LLC (the “Company”).


