ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

1. The Name of the limited liability company is Med Match L.L.C. (the "Company").

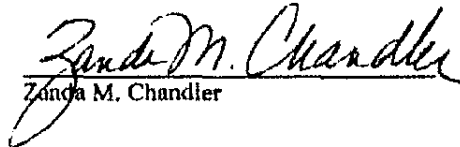
