ARTICLES OF ORGANIZATION

OF

RAINFOREST PROPERTIES, LLC.

ARTICLE I - NAME

The name of the Florida limited liability company shall be RAINFOREST PROPERTIES, LLC.

ARTICLE II - DURATION
