ARTICLE II - PRINCIPAL OFFICE


The mailing address and street address of the principal office of the Company is 3246 Touraine Avenue, Orlando, Florida 32812.

The Company is a manager-managed limited liability company and the initial manager of the Company is Coy Tipping.




