

ARTICLE I

Name

The name of the Limited Liability Company is HORSE POWER RANCH, LLC.

ARTICLE II

Address

The mailing and street address of the Company's principal office is 8180 Manasota Key Road, Englewood, Florida 34223.

ARTICLE III

Duration

The period of duration of the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV

Registered Agent and Office

The name of Company's initial registered agent in Florida is Robert M. Lowry. The address of Company's registered office in Florida is 8180 Manasota Key Road, Englewood, Florida 34223.

ARTICLE V

Management

The Company is to be managed by Robert M. Lowry and Kathleen N. Lowry. They will serve until the first annual meeting of the members. The initial manager is identified as follows:

ARTICLE VI

Admission of New Members

Continuation of Business



The business may be continued only on the unanimous written consent of the remaining members.

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article V.


