ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
KANDOR EQUESTRIAN LLC

The Articles of Organization of Kandor Equestrian LLC, a Florida limited liability company (the "Articles of Organization") filed on February 25, 2013 and assigned document L13000029119, shall be amended as follows:


Article I of the Articles of Organization shall be deleted in its entirety and the following shall be added in its place:

Article I - Name

The name of the limited liability company is Kandor Farm LLC (the "Company").
