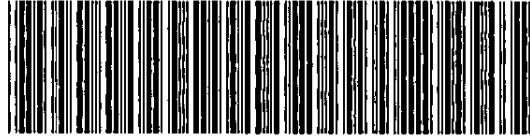

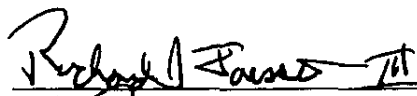
Article I is amended in its entirety to read as follows:

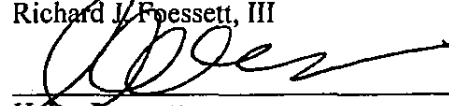
ARTICLE I
