The name and the Florida street address of the initial registered agent are: LOUIS A. DeMAY, 2595 Snowflake Lane, North Port, FL 34286.


**ARTICLE IV — Management:**

Pursuant to Section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.


