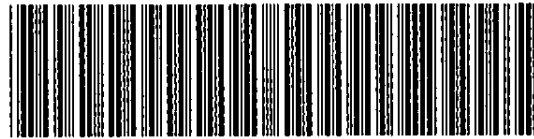

**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **ONLINE FINANCIAL RESOURCES, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.


6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial managers of the Company are as follows:
