**ARTICLES OF ORGANIZATION

**ARTICLE I.

The power to adopt, alter, amend, or repeal an operating agreement for the Company shall be vested in the Member(s) of the Company.

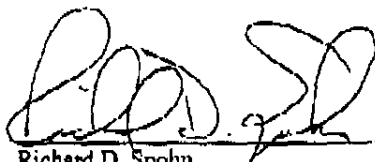
