The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members.



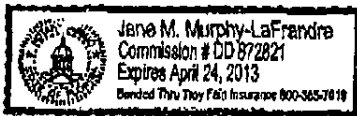
