**ARTICLE I
Name**

The name of this limited liability company is NEW GEORGIA LLC (the "Company").

**ARTICLE II
Existence**

**ARTICLE IV
Registered Agent and Address**

The principal office and mailing address of the Company is 2701 North Rocky Point Drive, Suite 900, Tampa, Florida 33607, and/or such other place or places as may be designated by the Managing Member from time to time. The name and address of the initial registered agent of the Company is Pennington, P.A., c/o Christian F. O’Ryan.

**ARTICLE V
Initial Members**

The initial members of the Company shall have the right to admit additional members upon the following terms and conditions.

1. Said members must wish to associate themselves with the Company;
2. Said members must pay an initial capital contribution in an amount to be established by the existing members; and
3. The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member of the Company, or the occurrence of any other event that terminates the continued membership of a member in the Company shall not result in the dissolution of the Company. Rather, the remaining members of the Company shall have the right to continue the business of the Company notwithstanding the foregoing events.

The name of the initial Managing Member who shall serve as Managing Member until the first annual meeting of the members or until its successor is elected and qualified is Christian F. O'Ryan.

Effective Date of Company**

The Effective Date of the existence of the Company shall commence on the date of execution and acknowledgment of these Articles of Organization, provided that these Articles of Organization are filed with the State of Florida Department of State within five (5) business days of such date. Otherwise, corporate existence shall commence on the date of filing of these Articles of Organization.
