## ARTICLES OF ORGANIZATION OF RAGGEDY ANN & ANDY KIDS KORNER, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

We further declare that the following Articles will serve as the Charter and authority for the conduct of business of the limited liability company.

#### ARTICLE I

Name and principal place of business. The name of the limited liability company shall be RAGGEDY ANN & ANDY KIDS KORNER, LLC, and its mailing address shall be 705 Ohio Avenue, Lynn Haven, Florida 32444 and its principal office shall be located at 705 Ohio Avenue, Lynn Haven, Florida 32444, but it shall have the power and authority to establish branch offices at any other place or places as their members may designate.

#### ARTICLE II
