

STATEMENT OF AUTHORITY FOR NOGFINCH, L.L.C. (A Florida limited liability company)

The undersigned, John Finch, an authorized representative of a Member of Nogfinch, L.L.C. (the "Company") submits the following statement of authority pursuant to §605.0302(1), Florida Statutes:

- 1. The name of the limited liability company is Nogfinch, L.L.C.
- 2. The Florida Document Number of the Company is L13000034927.
- 3. The street address of the Company's principal office is 4405 Commons Drive East, Suite 102, Destin, Florida 32541 and the Company's mailing address is P.O. Box 5846, Sarasota, FL 34277.
- 4. This statement of authority sets limitations of authority for Steven Bradley (the "Manager") while having the status or position as Manager of the Company as follows:

The Manager shall not be authorized to sell all or substantially all of the Company's assets without the written consent of seventy-five percent (75%) in interest of the Members of the Company pursuant to the terms and conditions of the Operating Agreement of the Company.

5. As of the date hereof, the sole asset of the Company is the real property owned by the Company located at LOT 8, BLOCK 4, DRAPER LAKE, A PLANNED UNIT DEVELOPMENT, SITUATED IN SECTION 2, TOWNSHIP 3 SOUTH, RANGE 20 WEST, ACCORDING TO THE MAP OR PLAT THEREOF, AS RECORDED IN PLAT BOOK 16, PAGE(S) 7-7B, OF THE PUBLIC RECORDS OF WALTON COUNTY, FLORIDA (the "Property"). The written consent of seventy-five (75%) in interest of the Members of the Company is required for the sale of the Property pursuant to the terms and conditions of the Operating Agreement of the Company, and the Manager has no authority to bind the Company to any agreement for the sale of such Property or to transfer legal title to the Property without the written consent of seventy-five percent (75%) in interest of the Members of the Company.
