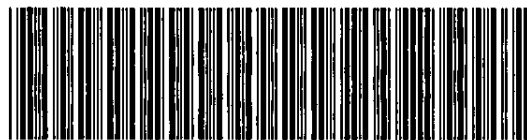


## LIMITED LIABILITY COMPANY RESOLUTION
