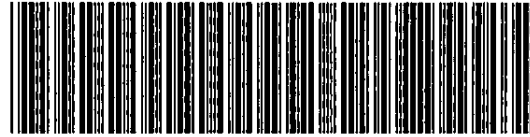

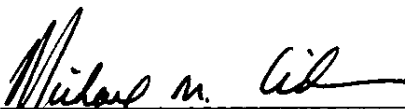

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be SOUTH ISLAND TABLES.COM, ~~LLC~~, and the mailing address and street address of its principal office shall be 77 Kindred Blvd., Port Charlotte, FL 33954, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II

PURPOSES AND POWERS

These Articles may be amended by a vote of a majority in interest of the members.

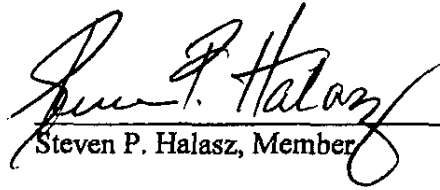

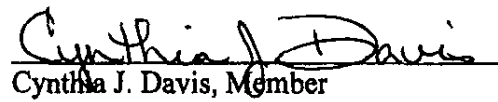

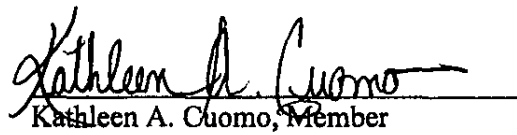
