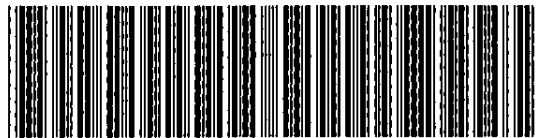

ARTICLE VII -- MANAGEMENT

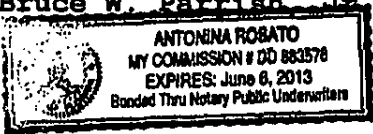
