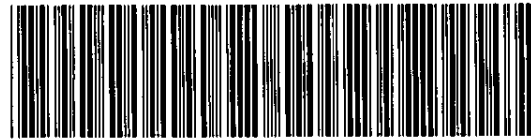

**SECTION 605.1045 OF THE FLORIDA REVISED LIMITED LIABILITY COMPANY ACT AND  
SECTION 18-214 OF THE DELAWARE LIMITED LIABILITY COMPANY ACT**

- 1) Treatment Concepts, LLC was a limited liability company first formed in Florida on March 8, 2013.
- 2) Pursuant to Section 605.1041 of the Florida Revised Limited Liability Company Act and Section 18-214 of the Delaware Limited Liability Company Act, Treatment Concepts, LLC has been converted from a Florida limited liability company to a Delaware limited liability company, effective as of January 21, 2015, under the terms and conditions of a Plan of Conversion ("Plan of Conversion") adopted by the written consent of the sole member of the LLC, and attached as Exhibit A hereto.
- 3) The name and type of business entity prior to the conversion was Treatment Concepts, LLC, a Florida limited liability company.
- 4) The name and type of business entity after the conversion is Treatment Concepts, LLC, a Delaware limited liability company.
- 5) The written consent of the sole member of the converted limited liability company was obtained in accordance with Chapter 605 of the Florida Limited Liability Company Act.
- 6) This conversion shall be effective in Florida upon the acceptance of the articles of conversion and certificate of formation by the Delaware Secretary of State on January 21, 2015.
- 7) The principal office of the converted limited liability company is 2901 Stirling Road, Suite 300, Fort Lauderdale, Florida 33312.
- 8) Treatment Concepts, LLC has agreed to pay any members having appraisal rights the amount to which they are entitled under Sections 605.1006 and 605-1061-1072 of the Florida Revised Limited Liability Company Act. Because the sole member approved the conversion, there should be no member of the LLC prior to the conversion that has appraisal rights.
