

SAMPLE STATE OF STATE The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, hereby sets forth the following:

- Name: The name of the limited liability company is 1442-16th, LLC (hereinafter referred to as the "Company").
- Unless earlier terminated under the Act or the Operating 2. Period of Duration: Agreement, the period of duration of the Company shall be perpetual.
