ARTICLES OF ORGANIZATION OF FLORIDA CORAL LIEN INVESTMENTS, LLC

a Florida limited liability company

This attachment is made to the Articles of Organization of Florida Coral Lien Investments, LLC (the "Company") to amend the Articles of Organization as follows:
