The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, hereby sets forth the following:

- 1. <u>Name</u>: The name of the limited liability company is 3250 Woods Edge, LLC (hereinafter referred to as the "Company").
- 2. <u>Period of Duration:</u> Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.
