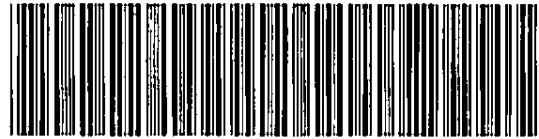

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF  
PLANT HEALTH CARE SYSTEMS OF SOUTH FLORIDA, LLC**

The Articles of Organization for this Limited Liability Company were filed on March 13, 2013 and assigned Florida document number L1300038683. These articles replace and restate the original articles.

Pursuant to the provisions of section 605.0202, Florida Statutes, this *Florida Limited Liability Company* adopts the following Amended and Restated Articles of Organization:

**ARTICLE I - NAME**

The name of the limited liability company ("LLC") is: **Plant Health Care Systems of South Florida, LLC.**

**ARTICLE II - DURATION**

The existence of the LLC shall be perpetual and shall begin on the date that the articles of organization were filed with the Florida Department of State.

The LLC is to be managed by the Members, and the names and addresses of the Members/Managers are as follows:

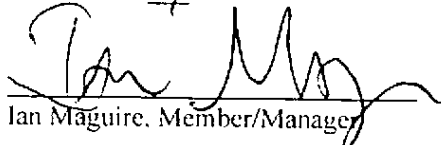

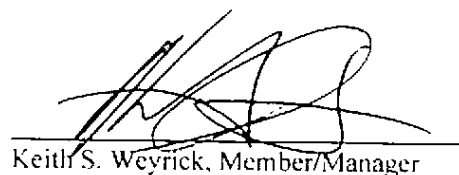
