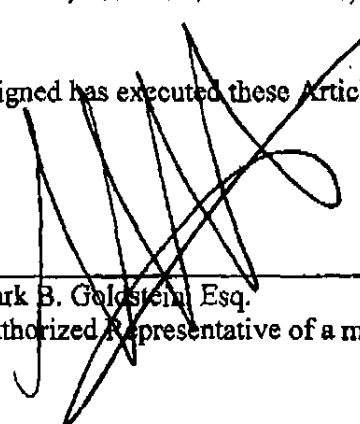
**ARTICLE V**
