**ARTICLES OF ORGANIZATION**  
**OF**  
**REX TRANSPORTATION, LLC**

Pursuant to the Provisions of the Florida Statutes, the undersigned organizer hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I**  
**NAME**

The name of the limited liability company is **REX TRANSPORTATION, LLC** (the "Company").

**ARTICLE II**  
**DURATION**

The Company shall have a duration from the date of organization until December 31, 2100, unless it is dissolved and its affairs wound up prior to that date in accordance with the Florida Limited Liability Company Act (the "Act").

**ARTICLE III**  
**PURPOSES**

The purpose for which the Company is formed is to engage in transportation and interstate commerce and to engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act. The Company is not to engage in any act or activity requiring any consents or approvals by law without such consent or approval being first obtained.


## **ARTICLE VI** **ADMISSION OF ADDITIONAL MEMBERS**




