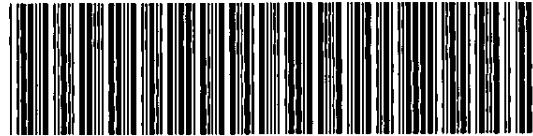

**ARTICLES OF ORGANIZATION
OF

Article 1. - Name

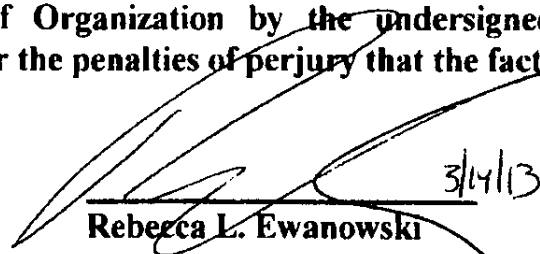

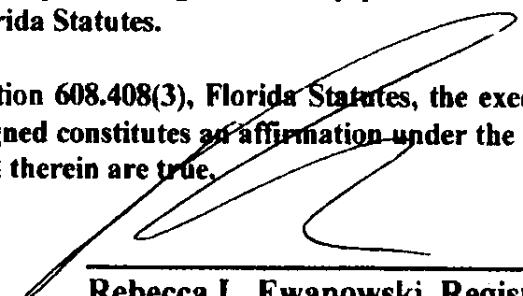
