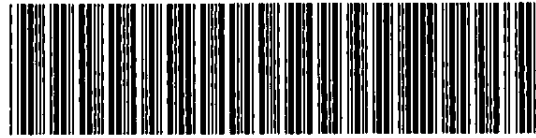


ARTICLE VIII
