These Articles of Amendment to the Articles of Organization of Gables Gate Tower, LLC, a Florida limited liability company (the "Company"), are hereby set forth the following in accordance with Section 605.0202 of the Florida Limited Liability Company Act:


FIRST: The Articles of Organization of the Company were filed on March 19, 2013 and assigned Florida document number L13000041145.
