ARTICLES OF ORGANIZATION OF ITSC, LLC

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following:

Articles of Organization.

ARTICLE 1 - NAME
