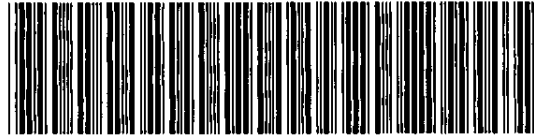

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION OF
UNIVERSAL RADIOLOGY SERVICES, LLC**

The undersigned certify that:

1. They are the members holding the majority-in-interest ("Members") of UNIVERSAL RADIOLOGY SERVICES, LLC, a Florida limited liability company, (the "Company") whose Articles of Organization ("Articles") were filed with the Secretary of State, State of Florida, on March 26, 2013.

2. The following Amendments to the Articles were adopted by written consent in lieu of a special meeting of the Members as authorized by Section 605.0201, Florida Statutes, by the Members on January 10, 2014.

3. ARTICLE II of the Articles is hereby deleted in its entirety and replaced with the following:

ARTICLE II

The street address and principal office of the Company is 1435 South Osprey Avenue, Suite 201, Sarasota, Florida 34239.

The mailing address of the Company is P.O. Box 15069, Sarasota, Florida 34277.

4. A new ARTICLE VII is hereby added to the Articles:

ARTICLE VII

Membership in the Company is hereby restricted to licensed health care practitioners or entities wholly-owned by licensed health care practitioners.

5. A new ARTICLE VIII is hereby added to the Articles:

ARTICLE VIII

The transfer, pledge, assignment or encumbrance of any kind, of any membership interest in the Company is prohibited without the prior written consent of the majority-in-interest of the Members of the Company. Any attempted transfer in violation of this Article VIII is void.
